- details that demonstrate the nominee's commitment of financial and/or human resources.

The categories for nomination are:

- Small Business (Fewer than 100 employees)
- Large Business (More than 100 employees)
- Individual/Foundation
- Arts Education (Individual, business, or organization that has demonstrated an extraordinary commitment to improving education through the arts)

The Paladin Achievement and Special Friends of the Council Awards are made at the discretion of the Awards Committee.
